Arrangement of Electronic Dissemination of Corporate Communications

Pursuant to Rule 2.07A of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules") under the expansion of paperless listing regime and electronic dissemination of corporate communications that came into effect on 31 December 2023, Bairong Inc. The Company is also required by the Listing Rules to send actionable corporate communications (the "Actionable Corporate Communications") to its shareholders individually in electronic form by email. "Actionable Corporation Communications" mean corporate communications that seek instructions from holders of its securities on how they wish to exercise their rights or make elections as the Company's shareholders. If the Company does not possess your email address or the email address provided is not functional, the Company will send the Actionable Corporate Communications in printed form together with a request form for soliciting the shareholders' functional email address to facilitate electronic dissemination of Actionable Corporate Communications in the future.
