Remarks:

The total number of issued shares (excluding treasury shares) as at 31 January 2025 was 491,564,686 (comprising 77,208,112 Class A ordinary shares and 414,356,574 Class B ordinary shares).

Bairong Inc. (the "Company") purchased a total of 25,313,000 class B ordinary shares during the period from 26 March 2024 to 28 November 2024 (the "Shares Repurchased") on the Stock Exchange. All the Shares Repurchased were subsequently cancelled on 28 February 2025 and the number of class B ordinary shares in issue was reduced by 25,313,000 shares as a result of the cancellation accordingly. Upon cancellation of the Shares Repurchased, the weighed voting rights ("WVR") beneficiary of the Company simultaneously reduced his WVR in the Company proportionately by way of converting his class A ordinary shares into class B ordinary shares on a one-to-one ratio pursuant to Rule 8A.21 of the Listing Rules, such that the proportion of shares carrying WVR of the Company shall not be increased, pursuant to the requirements under Rules 8A.13 and 8A.15 of the Listing Rules.
